Leads recreation planning efforts. Prepares written and oral reports, makes suggestions and recommendations for inclusion in reports.

Leads or participates as recreation specialist on inter-disciplinary team for analysis of projects, prepares National Environmental Policy Act (NEPA) documents and correspondence. Projects vary in complexity and include, but are not limited to, timber thinning, watershed restoration, recreation facility enhancement, recreation events, special uses, invasive plant control, and fuels reduction.

Prepares prospectii and coordinates prospectus evaluations.

Prepares and manages recreation events through special use permits.

Manages outfitting and concessionaire permits, including field inspections.

Selects appropriate guidelines and determines which legal, regulatory, and other requirements apply to particular situations.

Coordinates National Visitor Use Monitoring efforts.

Works closely with recreation staff and planning staff members.
